## **GO Hillsborough to Host 54 Additional Meetings in Libraries across the County**

Focus will be on ½% and 1% Project Lists for Community Transportation Plan

**Tampa, Fla.** – GO Hillsborough is kicking off another round of community engagement this week. Beginning August 17, residents, homeowners associations, civic organizations and businesses throughout Hillsborough County will have multiple opportunities, including through online and social media channels, to actively participate in finalizing a Community Transportation Plan and its projects for the next 10 years. Most importantly, participants will have an opportunity to weigh in on a critical community decision: a ½% sales tax increase to fund needed but basic transportation improvements; or, a 1% sales tax increase which will bring more transit options, better jobs, and an improved quality of life.

"We've received a lot of solid feedback in support of a ½% sales tax funding strategy to deliver the core projects in this Plan; however, we also know that a 1% sales tax could do so much more to create prosperity for our community," said Mike Merrill, Hillsborough County Administrator. "Now, we want to make sure that our citizens understand what a ½% actually can fund, and the critically important projects it cannot."

These additional 54 community meetings will also identify the specific projects as well as the funding strategy. The meetings are planned at libraries – 2 in each of 22 libraries -- throughout the county and cities during both day and evening hours, including several Saturday mornings. The meetings will run during August through mid-October 2015.

Building on an unprecedented community engagement effort, including focus groups, community workshops, and public opinion surveying, residents recognize there is a transportation crisis looming. And, they've also strongly indicated that they want new and improved roads, congestion and bottleneck relief, and improved traffic flow and transit choices.

"We fully intend to ensure that new growth will pay a greater and more equitable share of future transportation infrastructure and that existing gas tax revenue and even some ongoing general government revenue will continue as funding sources, but the reality is those are relatively small shares of the total cost," Merrill emphasized. "The key to stopping this ongoing decline in our quality of life--and avoiding a transportation crisis--is the modest investment you can make with a sales tax that's also paid by visitors to our community."
